Subject: - Reg. use of the word "University" and award of degrees by fake universities/Institutions in violation of UGC Act, 1956.

Dear Sir/Madam,

The University Grants Commission has been receiving complaints against the institutions which are not "University" within the meaning of Section 2(f) or Section 3 of University Grants Commission Act, 1956 but are conferring the degrees or using the word "University" with their names and are defrauding and cheating innocent students by awarding fake/invalid degrees. The UGC has been publishing the list of fake universities existing/functioning across the country in the News Papers and is also uploading it on its website (www.ugc.ac.in) to warn the students not to take admission in such universities. A copy of the list is enclosed.

You are requested to inform the current status of these and such other unrecognized institutions existing/functioning in your State. You are also requested to take suitable action against them and register an FIR in the police station within the jurisdiction of which, the institute is located. In case, any of these fake Institutions are not existing now, the information with due proof, may be sent to UGC to enable UGC to process the case for removing its name from the list of fake universities maintained by UGC.
